# Labour market in the regions of the UK: September 2021

Regional, local authority and Parliamentary constituency breakdowns of changes in UK employment, unemployment, economic inactivity and other related statistics.

## **Notice**

## 30 September 2021

Due to a calculation error in the method used to reweight the Labour Force Survey, which uses a three-month rolling average of RTI data, there is a lag of one month. Our analysis shows the impact on the population levels and headline labour market levels estimates is, though, very small with the published headline labour market rates unchanged. The impact on LFS estimates for employment, unemployment and economic inactivity level at UK level is mostly below 0.1% and the impact on rates is less than 0.02 percentage points.

# 2. Main points

- In August 2021, only London, Scotland and the South East had fewer payrolled employees then before the start of the pandemic; London is the furthest behind its pre-pandemic levels but saw the largest increase between July and August.
- For the three months ending July 2021, the highest employment rate estimate in the UK was in the East of England (78.7%) and the lowest was in Northern Ireland (71.2%). The East of England has had an increase of 1.1 percentage points, which is the the largest increase compared with the same period last year; both the East of England and Wales now have employment rates above pre-pandemic levels (December to February 2020).
- For the three months ending July 2021, the highest unemployment rate estimate in the UK was in London (6.0%) and the lowest was in the South West (3.3%); Wales and Northern Ireland saw the largest increases compared with the previous year, both at 1.0 percentage point.
- For the three months ending July 2021, the highest economic inactivity rate estimate in the UK was in Northern Ireland (25.7%) and the lowest was in the East of England (18.3%); Wales saw the largest decrease in the economic inactivity rate compared with last year, at 1.7 percentage points, with the rate of 22.0% being the lowest since April to June 2019.
- For the 12 months ending March 2021, average weekly hours worked varied between London, with 30.2 million hours worked, and the North East, with 27.3 million hours worked; all regions saw a decrease in the average weekly hours worked compared with the same period last year, with the North West and West Midlands both seeing the largest decreases of 4.2 hours per week; for total weekly hours worked, the South East saw the largest decrease compared with the same period last year, down 21.1 million hours per week.
- Between March and June 2021, workforce jobs increased in most regions of the UK, with the largest increase of 75,000 seen in London; Northern Ireland and the South East were the only regions to see decreases in workforce jobs; of 6,000 and 5,000 respectively; London has the highest proportion of servicebased jobs, at 91.9%, while the highest proportion of production sector jobs is in the East Midlands, at 12.3%.

# 5. Glossary

### Actual and usual hours worked

Statistics for <u>usual hours worked</u> measure how many hours people usually work per week. Compared with <u>actual hours worked</u>, they are not affected by absences and so can provide a better measure of normal working patterns. For example, a person who usually works 37 hours a week but who was on holiday for a week would be recorded as working zero actual hours for that week, while usual hours would be recorded as 37 hours.

## **Economic inactivity**

People not in the labour force (also known as <u>economically inactive</u>) are not in employment but do not meet the internationally accepted definition of unemployment because they have not been seeking work within the last four weeks and/or they are unable to start work in the next two weeks. The economic inactivity rate is the proportion of people aged between 16 and 64 years who are not in the labour force.

## **Employment**

<u>Employment</u> measures the number of people in paid work or who had a job that they were temporarily away from (for example, because they were on holiday or off sick). This differs from the number of jobs, because some people have more than one job. The employment rate is the proportion of people aged between 16 and 64 years who are in employment. ## Local labour market indicators

Local labour market indicators cover employment, unemployment, economic inactivity and jobs density for subregional geographical areas such as local and unitary authorities, counties and regions in the UK for the most recent 12-month period available of the Annual Population Survey (APS). The jobs density of an area is the number of jobs per head, of resident population, aged 16 to 64 years.

## Pay As You Earn (PAYE) Real Time Information (RTI)

These data come from HM Revenue and Customs' (HMRC's) Pay As You Earn (PAYE) Real Time Information (RTI) system. They cover the whole population rather than a sample of people or companies, and they will allow for more detailed estimates of the population. The release is classed as Experimental Statistics as the methodologies used to produce the statistics are still in their development phase. As a result, the series are subject to revisions.

PAYE is the system employers and pension providers use to take Income Tax and National Insurance contributions before they pay wages or pensions to employees and pensioners. This publication relates to employees only and not pensioners.

## Unemployment

<u>Unemployment</u> measures people without a job who have been actively seeking work within the last four weeks and are available to start work within the next two weeks. The unemployment rate is not the proportion of the total population who are unemployed. It is the proportion of the economically active population (those in work plus those seeking and available to work) who are unemployed.

# 6. Measuring the data

This bulletin relies on data collected from the Labour Force Survey (LFS), and the Annual Population Survey (APS) derived from it, the largest household survey in the UK.

# 7. Strengths and limitations

The estimates presented in this bulletin contain <u>uncertainty</u>. The Labour Force Survey (LFS) gathers information from a <u>sample of households</u> across the UK. The sample is designed to be as accurate as possible given practical limitations. This can have an impact on how changes in the estimates should be interpreted, especially for short-term comparisons.

As the number of people in the sample gets smaller, the variability of the estimates that we can make from that sample gets larger. Estimates for small groups, which are based on small subsets of the sample, are less reliable and tend to be more volatile than for larger aggregated groups.

In general, changes in the numbers (and especially the rates) reported between three-month periods are small and are not usually greater than the level that is explained by sampling variability. For a fuller picture, short-term movements in reported rates should be considered alongside longer-term patterns in the series and corresponding movements in other sources.

The data in this bulletin follow internationally accepted definitions specified by the International Labour Organization (ILO). This ensures that the estimates for the UK are comparable with those for other countries. Our <u>reconciliation report of job estimates article</u>, which compares the latest Workforce Jobs estimates with the equivalent estimates of jobs from the LFS (published every March), has been postponed until further adjustments are made.
