As discussed on the phone, I am writing to confirm that we wish to cancel tomorrow's meeting. At this stage in the Assessment process it is more appropriate for detailed discussions to take place between the producers and the assessors to clarify points of accuracy and detail.

The offer to give you briefing was in the context of the original plans i.e. for us to brief the May Assessment Committee for a rapid decision in advance of the proposed publication, as we needed to work in parallel and at speed. We think this is unnecessary now we have a more normal timetable with your publication in October and the assessment report going to the Assessment Committee in July.
