Thanks, can you tell me if you consider the documents already sent as drafts, or as final evidence? I appreciate the assurance framework will be draft, and apologies if you've mentioned this for the other documents in your emails and I have missed it on the BlackBerry.

The reason I ask is that if they are final it makes more sense for us to consider them together with the forthcoming documents against the Code (due to the degree of overlap and links between the documents). If they are still drafts and you expect to send further versions we could consider them separately as you send them through and provide drafting comments.

Without that confirmation I've taken them to be in draft development, and having discussed with the team and senior management we consider that we could aim to get a response to you on the user guide and draft sample text by the end of the week, barring unforeseen circumstances. For any further documents it would be late next week.
