Afternoon,

Thanks for coming to meet with us yesterday. The timetable you set out for the re-assessment was significantly shorter that we had been expecting, which raises a number of challenges for us. We had been expecting a more focussed exercise on assurance that the issues identified in England and Wales were not happening in Scotland prior to our publication, followed by the more resource intensive work after our publication. In normal times, we would naturally allocate a degree of resource to support a re-assessment exercise. However, this is not possible at present as our resources are focussed on our primary goal of producing the recorded crime statistics. As you will know, we are currently undertaking an essential and extensive exercise in collaboration with Police Scotland on the processes used to submit their data. This is, of course, the first year the Police Scotland has submitted data. I am sure you would support our use of resources to complete this exercise.

In order that we use our limited available time as helpfully as possible, it is important that I have a good understanding of the re-assessment process that you will be following. I am afraid that, at present, I do not have such an understanding, so I would appreciate your help in getting me upto-speed. I appreciate that the underlying structure for any assessment is the "Code of Practice for Official Statistics", however there are numerous ways that one could go about conducting such an assessment exercise. I would like to have good understanding of your plans for conducting such an assessment exercise - in essence the specification for this work. I have listed below the type of information that would be helpful:

- What criteria will be used to conduct the assessment?
- What evidence from what source will be collected against each of these criteria?
- How will the evidence be analysed to derive findings?
- What elements of the re-assessment will be reported to the May Assessment Committee?
- What elements of the re-assessment will be reported to the July Assessment Committee?
- What will be the format of the final re-assessment report? Will this be a WEFA?
- When, and for how long, will we have to comment on the information contained in reports

to the (i) May Assessment Committee; (ii) the July Assessment Committee; and (iii) the final report.

I think that having such an understanding of the process that you are intending on following will assist our future communications and coordination of our resources.




