Thanks for your note

I am afraid work pressures make it impossible for us meet his week. As you know this is a particularly resource intensive time, which does makes your timetable really challenging for us.

Thanks for your question list, which contains a detailed and wide ranging list of questions. Is there any way that you could prioritise these questions, and help us to target our limited resources on the most critical areas for May first? It would then be helpful for us to discuss how best to provide this information. Due to the office move and other work commitments, the team have not been able to touch base this week on these issues. We will need to regroup next week and consider how to accommodate your requests without jeopardising the on-time publication of "Recorded Crime in Scotland".

We are committed to working with you to ensure that this process leads to a robust evidence-based conclusion. At present, we do not understand the re-assessment process in the level of detail that would allow us to make a judgement as to whether a wefa was or was not required. In order to address this issue, it would be helpful to have a specification for this work. I imagine such a specification would make it clear whether a wefa was or was not required to meet the aims of the re-assessment. If a wefa was required, we would like to discuss how to achieve this given our resource constraints. I am afraid that we have to be careful how we use our resources at present, as the successful delivery of the 2013/14 report is at risk and this must be prioritised.

It is unfortunate that this re-assessment has come about at such a busy time for us, in other times I am sure this process would be easier for both of us.

At our last meeting you noted that your resources were limited, and we agreed that we would undertake a review of ongoing Code compliance for these statistics, and would then advise you of any queries that arose from this.
