

Hi and ,

Thanks for sending us the extract to review. I've made some general comments below, but I've also attached an annotated version of the extract, which includes some more detailed points.

- We can see that there has been some progress in trying to address the requirements from the assessment report, but feel like there is still work to do in order to fully meet them. The most important thing is to think about is your story-telling and narrative. What are the most important and interesting stories that you want people to take away from the statistics? What is the best way to structure the overall release and the individual paragraphs to help tell these stories?
- To help tell the story, you could consider whether there are more everyday terms that you could be
  using, rather than the specific terminology that's used to record crime. E.g. could you call non-sexual
  violent crimes just violent crime? You can explain what it covers in an introductory sentence for the
  relevant section of the release, so this would make it clear that it doesn't include sexual crimes.
- It's great that you've included information from the SCJS, but it still feels quite separate to the statistics on recorded crime. Could you try to combine the two sets of information in the commentary? This would help to present a more comprehensive and coherent story on what is happening to crime in Scotland. - A lot of the extract focuses on the local authority analysis, most of which looks at the change in crime over the last year. Is there a danger of drawing attention to very small changes? The longer trend would be more interesting. Or a higher level discussion of geographic differences in crime (for example rural vs urban). Chart 4 helps to show the diversity of changes across the ten year period (-29% to -54% is a big difference), but 31 local authorities is a lot to include in one chart.
- We'd quite like to see the key points section, when this has been written.

As we've only seen an extract of the release, it's difficult to understand how all the pieces will fit together. Some of our comments might relate to things that have been addressed elsewhere in the release. We'd also be interested in knowing if the following things are dealt with in the release:

- How will offences be treated in the release? Will you look at the overall picture of crime and offences together?
- Do you explain why these statistics are important? How are they used?
- What level of uncertainty is there in the data? Can you quantify this in any way for your users?
- Where should users go to find out more information? (detailed data tables, quality reports, methodological info, related statistics, etc)


