1 . Main points

- The number of deaths registered in England and Wales was affected by the Summer Bank Holiday, with 8,797 deaths registered in the week ending 3 September 2021 (Week 35); this was 1,471 fewer deaths than the previous week (Week 34) and 6.7% above the five-year average (556 more deaths).
- The number of deaths registered in England in the week ending 3 September 2021 (Week 35) was 8,234; this was 1,396 fewer deaths than the previous week (Week 34) and 7.3% above the five-year average (560 more deaths).
- The number of deaths registered in Wales in the week ending 3 September 2021 (Week 35) was 542; this was 74 fewer deaths than the previous week (Week 34) and 0.6% above the five-year average (3 more deaths).
- Of the deaths registered in Week 35 in England and Wales, 659 mentioned “novel coronavirus (COVID-19)”, accounting for 7.5% of all deaths; this was a decrease compared with Week 34 (668 deaths).
- The number of deaths involving COVID-19 in England decreased to 632 in Week 35 compared with 649 in Week 34; for Wales, deaths involving COVID-19 increased to 25 in Week 35 compared with 16 in Week 34.
- The number of deaths registered in the UK in the week ending 3 September 2021 was 10,307, which was 828 more than the five-year average; of deaths registered in the UK in Week 35, 781 involved COVID-19, that is, 12 more than in Week 34.

Week 35 included the Summer Bank Holiday (Monday 30 August 2021) so differences between Week 34 and Week 35 should be treated with caution. Comparisons with the five-year average should also be interpreted with caution as the Summer Bank Holiday has fallen in both Week 35 and Week 36 since 2015.

The provisional number of deaths registered in England and Wales decreased from 10,268 in Week 34 (week ending 27 August 2021) to 8,797 in Week 35 (week ending 3 September 2021). Week 35 included a bank holiday (Summer Bank Holiday) when register offices are likely to be closed. Therefore, trends should be interpreted with caution in this week's and next week's publication.

The number of deaths was 6.7% above the five-year average (556 more deaths) in England and Wales. The Summer Bank Holiday appears in different weeks depending on the year; it was in Week 35 in 2016, 2017, 2018 and 2019, whereas it was in Week 36 in 2015. Comparisons with the five-year average should be treated with caution for Weeks 35 and 36.

In England, the number of deaths decreased from 9,630 in Week 34 to 8,234 in Week 35, which was 560 more deaths (7.3% higher) than the Week 35 five-year average (Figure 1). Of these, 632 deaths involved coronavirus (COVID-19) in Week 35, a 2.6% decrease compared with Week 34 (649). Of all deaths registered in Week 35 in England, 7.7% mentioned COVID-19 on the death certificate.

In Week 35 (week ending 3 September 2021), the total number of deaths registered decreased compared with Week 34 (week ending 27 August 2021) in all regions of England. The largest decrease was reported in the South East (430 fewer deaths).

The numbers of deaths involving COVID-19 increased in five of the nine English regions in Week 35. The largest increase was reported in the East Midlands (18 more deaths). In Wales, the number of deaths decreased from 616 in Week 34 to 542 in Week 35, which was 3 more deaths than the Week 35 five-year average (Figure 1). Of these, 25 deaths involved COVID-19 in Week 35, compared with 16 in Week 34. Of all deaths registered in Week 35 in Wales, 4.6% mentioned COVID-19 on the death certificate.

Analysis in this section includes deaths from Week 11 of 2020 (week ending 13 March 2020, the week of the first registration of a death involving COVID-19) through to Week 35 of 2021 (week ending 3 September 2021), to ensure full coverage of the ongoing coronavirus pandemic.

Using the most up-to-date data we have available, the number of deaths from the week ending 13 March 2020 up to 3 September 2021 was 891,028 in England and Wales. Of these, 145,066 (16.3%) mentioned COVID-19 on the death certificate. During this period, the number of excess deaths above the five-year average was 111,151.

In England, the number of deaths between the weeks ending 13 March 2020 and 3 September 2021 was 835,551; of these, 136,814 deaths (16.4%) mentioned COVID-19. This was 106,970 deaths above the five-year average.

In Wales, the number of deaths for the same period was 54,363; of these, 8,046 deaths (14.8%) mentioned COVID-19. This was 5,336 deaths above the five-year average.

In Week 35, the number of deaths in private homes was 21.7% above the five-year average (439 excess deaths) and deaths in hospitals were 5.8% above the five-year average (215 excess deaths). Deaths in care homes were 1.0% below the five-year average (17 fewer deaths) and deaths in other settings were 11.1% below the five-year average (81 fewer deaths).

Across the UK, there were 10,307 deaths (all causes) registered in Week 35 (week ending 3 September 2021), which was 828 more deaths than the UK five-year average and 1,376 fewer deaths than in Week 34 (week ending 27 August 2021).

Deaths were above the five-year average in England (560 more deaths), Scotland (187 more deaths), Northern Ireland (85 more deaths) and Wales (3 more deaths). Of all deaths in the UK in Week 35, 781 involved coronavirus (COVID-19), 12 more deaths than in Week 34, a 1.6% increase.

In Week 35, England had the highest number of deaths involving COVID-19 with 632 deaths, followed by Northern Ireland (64 deaths), Scotland (58 deaths) and Wales (25 deaths).

5 . Glossary

Coronavirus (COVID-19) deaths

Coronavirus (COVID-19) deaths are those deaths registered in England and Wales in the stated week where COVID-19 was mentioned on the death certificate. A doctor can certify the involvement of COVID-19 based on symptoms and clinical findings – a positive test result is not required. Definitions of COVID-19 for deaths in Scotland and Northern Ireland are similar to England and Wales.

6 . Measuring the data

To meet user needs, we publish very timely but provisional counts of death registrations in England and Wales in our [Deaths registered weekly in England and Wales, provisional dataset](#). These are presented:

- by sex
- by age group
- for regions (within England)
- for Wales as a whole

To allow time for registration and processing, figures are published 11 days after the week ends. Because of the rapidly changing situation, we also provide provisional updated totals for death occurrences based on the latest available death registrations, up to 11 September 2021.

Coronavirus

This weekly release now provides a separate breakdown of the number of deaths involving coronavirus (COVID-19); that is, where COVID-19 or suspected COVID-19 was mentioned anywhere on the death certificate, including in combination with other health conditions.

If a death certificate mentions COVID-19, it will not always be the main cause of death but may be a contributory factor. This bulletin summarises the latest weekly information and will be updated each week during the pandemic.

Data coverage

The data for 2020 are based on a 53-week year. Because the number of days in a week is seven, when there are 52 weeks, we only cover 364 days of the 365 days in the year, which results in one remaining day each calendar year not included in the 52 weeks. With the occurrence of leap years, it is sometimes necessary to add a 53rd week to the end of the calendar, which was the case in 2020. This happens every five years – the last time there was a Week 53 was in 2015. Given the low frequency of Week 53, it is more appropriate to compare the 2020 figures with the average for Week 52 than to compare it with a single year from five years previous. Influenza and pneumonia has been included for comparison in the [Deaths registered weekly in England and Wales dataset](#) as a well-understood cause of death involving respiratory infection that is likely to have somewhat similar risk factors to COVID-19.

Registration delays

This bulletin is based mainly on the date deaths are registered, not the date of death, because of the time taken for a death to be registered. Deaths in England and Wales are normally registered within five days, but there can be a considerably longer delay in some circumstances, particularly when the death is referred to a coroner. We have developed a statistical model to estimate the number of deaths likely to have occurred in each week based on previous experience of the pattern of registration delays, including the effects of bank holidays. Classification codes

From the week ending 26 February 2021 (Week 8), new International Classification of Diseases (ICD-10) codes for COVID-19 issued by the World Health Organization (WHO) were implemented for deaths involving COVID-19. 7 . Strengths and limitations

Comparability

These weekly figures are for England and Wales only (as this is the Office for National Statistics' (ONS') legal remit). They are from the formal death registration process and may include cases where the doctor completing the death certificate diagnosed possible cases of coronavirus (COVID-19), for example, where this was based on relevant symptoms, but no test was conducted. The ONS figures are different from the [daily surveillance figures on COVID-19 deaths published by the Department of Health and Social Care \(DHSC\)](#) on GOV.UK, which are for the UK as a whole and its constituent countries.

From 29 April 2020, the DHSC published improved data for England from Public Health England (PHE) to include a count of all deaths, regardless of location, where a positive COVID-19 test was confirmed. Previously, only confirmed COVID-19 deaths in hospitals were reported. This improved the comparability with figures for Scotland, Wales and Northern Ireland, where deaths outside of hospitals were already being included, and ensured that the UK-wide series had a shared and common definitional coverage. On 12 August 2020, the PHE data series was revised to include deaths of positively tested individuals where the death occurred within 28 days, and deaths within 60 days of a positive test. The [Public Health England technical summary \(PDF, 854KB\)](#) provides more detail on these changes.
